HALLOWEEN COSTUME RULES and GUIDELINES
October 31, 2022

All students wearing costumes to school MUST read and understand the Costume Rule/Guidelines. In addition, they MUST sign the registration form provided by SBA. On October 31, students are to receive clearance in the morning in front of Mrs. Guerrero's office. They must also have this form signed by a parent/guardian to receive clearance. Students who receive clearance will receive a band and must be worn the entire day. If this form is not signed by parents, students will have to change in school uniform.

1. All costume preparations are to be completed at home. (No dressing or applying make-up or colored hairspray once students arrive at school).
2. No masks or full-face paint are to be worn during the school day.
3. NO COSTUMES THAT DEPICT VIOLENCE OR VIOLENT CHARACTERS! Fake blood is not allowed.
4. NO costumes that promote the use of illegal substances or activities, or are derogatory or disrespectful.
5. NO weapon-like props are allowed. Teachers may take away any accessory that is used improperly or is considered inappropriate for school.
6. **School rules regarding the dress code must be followed.** This includes appropriate length for bottoms and appropriate tops.
7. Students who have questions about the acceptability of their costume should check with the SSO or SBA Advisors.
8. Students wearing **inappropriate** costumes will be sent to the office to call home for a change of clothes, and/or may result in any of the following disciplinary consequences: Work Detail, Parent Shadow, or Suspension.
9. Students who do not submit parent agreement form by the Monday, October 31st deadline and still choose to wear a costume will also face disciplinary action as deemed appropriate by administration.
10. Costumes MUST be worn all day.
